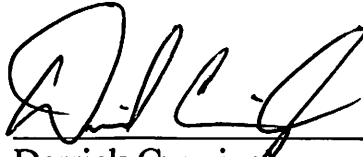


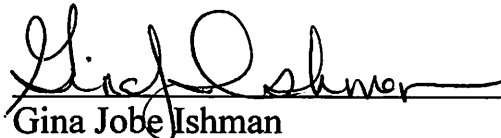
Montgomery County, Alabama

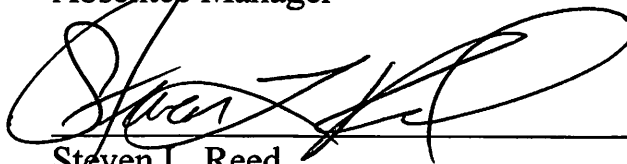

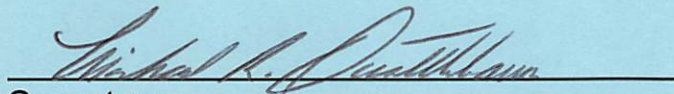
