ATHLETIC WAIVER AND RELEASE OF LIABILITY

In consideration of being allowed to participate in any way in the Reggie Barlow Co-Ed Football Skills Camp and the Montgomery County Commission athletics/sports program, and related events and activities, the undersigned:

1. Acknowledge and fully understand that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from their own actions, inactions, or negligence but the action, inaction, and negligence of others, or the condition of the premises or of any equipment used. Further, that there may other risks not known to us or not reasonably foreseeable.
2. By signing this waiver, the parent/legal guardian assumes the risk, and takes full responsibility and waives all claims of personal injury, permanent disability or death of themselves or their minor child while participating in the Reggie Barlow Co-Ed Football Skills Camp.
3. Release, waive, discharge and covenant not to sue the Reggie Barlow Co-Ed Football Skills Camp and the Montgomery County Commission, their affiliated clubs, administrators, directors, agents, and employees, other members/participants, sponsoring agencies, advertisers, owners and lessors of the premises used to conduct the event, all of which are hereinafter referred to as "releasees," from all liability to each of the undersigned, their heirs, and next of kin, for all claims, demands, losses, or damages on account of accidents, mishaps or injury including death and damage to property, caused or alleged to be caused in whole or in part by the acts or negligence of the releasees or otherwise.

To the best of my knowledge, the below-named minor does not have any physical limitations, medical conditions, physical or mental disabilities that would limit or prevent him/her from participating in the Reggie Barlow Co-Ed Football Skills Camp and the Montgomery County Commission athletics/sports program.
5. I hereby state that the Reggie Barlow Co-Ed Football Skills Camp and the Montgomery County Commission is not responsible for any pre-existing injury or reoccurrence of any undisclosed pre-existing injury or illness of the Participant prior to the date of the event. I understand that the Reggie Barlow Co-Ed Football Skills Camp and the Montgomery County Commission have purchased camp insurance and their liability for injury is limited to injuries actually received at the event and are limited to the policy limits for approved claims by the insurer.

Agree that the parent(s) and/or legal guardian(s) and the minor participant(s) that prior to participating they should inspect the facilities and equipment to be used, and if they believe anything is unsafe, they should notify the coach or supervisor of such condition(s) and refuse to participate.
