

GUIDELINES TO FILE FOR LETTERS OF ADMINISTRATION

IN ORDER TO FILE FOR ADMINISTRATION, THE COURT NEEDS THE FOLLOWING:

- 1) **Certificate** (Found in Personal Representative Handbook)
- 2) **Petition for Letters of Administration**
- 3) ***Personal Representative Bond (For more information, see below.)**
- 4) **Certified copy of Death Certificate**
- 5) **\$141.00 Filing Fee** (We accept cash, money order, MasterCard or Visa)
NO PERSONAL CHECKS ACCEPTED

(The filing fee includes \$45.00 for Court Cost and \$96.00 for Notice to Creditors)

REQUIREMENTS:

- 1) PETITIONER MUST BE AN ALABAMA RESIDENT.
- 2) PERSONAL ESTATE MUST BE ITEMIZED SEE FOLLOWING EXAMPLE:
Regions Bank \$0.00, 1940 Chevrolet Silverado \$0.00, furniture \$0.00, Jewelry \$0.00
- 3) **BOND** - CONTACT INSURANCE COMPANY AND THEY WILL ISSUE THE BOND.
(Sample bond form available on website listed below.)
 1. The amount of bond is the **Total of Rental Income and Personal Estate** figured as follows: *** (Note: A minimum bond of \$10,000 is required.)**
 - One year's estimated rental income on real property
 - One year's estimated income from investments (stocks, bonds)
 - Total value of personal property (vehicles, cash/investments, household items, stocks/bonds, etc.)
 - **Important:** Do not include property in the bond amount (such as real estate) that cannot be disposed of without court order or securities deposited under arrangements requiring an order of the court.
 2. **The name of the deceased and the name of the Personal Representative on the bond must agree with the names on the Petition for Letters of Administration.**
