Additional fees may apply, see fees for other services. **Extra:** Hearings, notices, and postage are \$2.50 per page + postage cost. Additional certified copies of letters are \$2.00. Additional fees may apply, see fees for other services.

- **(50) Other official duties not specified:** Up to \$500 annually, as allowed by the county commission.
- **(51) Commissions on state and county licenses:** 5% of the amount collected and paid over.
