Scope and Content: This record group consists of records created by the Montgomery County, Alabama Revenue Commissioner in the course of conducting their normal business. The record group mostly consists of county property valuation notices, and property assessment books. The record group also holds property tax plat books, some tax assessor records, land record books, and right-of-way records. In 1982 Alabama voters approved legislation allowing counties to combine the office of tax assessor and tax collector into the office of revenue commissioner.

System of Arrangement: The Alabama Department of Archives and History (ADAH) creates manuals called records disposition authorities (RDA) to help those responsible for state and local records in Alabama manage the records under their control. The RDAs evaluate records produced by various government entities, such as the Montgomery County Revenue Commissioner, and determines what, and how long, archives have to keep various records. In the course of doing so, the RDAs group records based on their various functions. Accordingly, this finding aid has organized the records in the Montgomery County Revenue Commissioner Record Group based on the function they helped serve, or that which created them.

Conditions Governing Access: If materials containing personal information, such as social security numbers, are present in the collection, requests for copies of said material will require redaction of such information before the archivist makes copies.

Conditions Governing Reproduction and Use: It is presumed corporate and individual copyrights have been retained by copyright owners. Copyright restrictions apply. Users of materials should seek necessary permissions from the copyright holders to comply with U.S. copyright laws.

Accruals: Future accruals expected.

Languages and Scripts: The entire collection is recorded in English.
